- Before starting your application, please contact the International Office of your home university and apply for pre-selection
- Once you have been declared eligible by your home university you must fill in an online application file on www.hec.edu/MiM:
 1. Create your account
 2. Select "Master's Programs"
 3. Select "GE/MiM - Master in Management program Grande Ecole"
 4. Select "GE/MiM - Only HEC International partners pre-selected candidates"
 5. Select your school
 6. Complete your application form and submit.
